- The number of share equivalents reported was determined by dividing the dollar amount credited to the Reporting Person's account by \$104.19 (the closing price for Hanesbrands Inc. common stock on the valuation date of October 14, 2014).
- The balance is determined by dividing the value in the Reporting Person's account following the reported transaction by \$104.19 (the closing price for Hanesbrands Inc. common stock on the transaction date of October 14, 2014).
